PROGRAM CHAIR'S REPORT



Our final meeting of 2025 for the Philadelphia Orthopaedic Society was held on December 8 where we were joined by Dr. Steven Frick. As noted in last month's newsletter, Dr. Frick has a very accomplished history of leadership within many levels of orthopaedic surgery and provided a great lecture on professionalism within your practice. There was something for everyone to take to improve their practice and our profession and we appreciate him sharing his wisdom.

As we enter the New Year, we will not meet until February at which point we have the pleasure of hosting Dr. Matthew Ramsey. Dr. Ramsey should be familiar to most members of the Society as he has practiced his entire career in the Philadelphia area. As a native New Yorker, Dr. Ramsey received his undergraduate degree from SUNY Binghamton, followed by medical school at SUNY Downstate in Brooklyn and his general surgery internship at Long Island Jewish. He then came to Philadelphia for his orthopaedic residency, where he has since been much to the benefit of all of us in the Philadelphia area. He has trained countless residents and fellows and is recognized as a pre-eminent expert in shoulder, and particularly elbow, surgery.

With such an illustrious career in orthopaedic surgery Dr. Ramsey has found another passion at which to excel. 




